## MEMORANDUM OF UNDERSTANDING BETWEEN IIT MANDI, Himachal Pradesh AND

AIIMS, Bilaspur, Himachal Pradesh

This MoU is made between AIIMS Bilaspur (addressed through authorised signatory) herein after called first party and IIT Mandi (addressed through authorised signatories), herein after called second party which expressions qua both parties shall unless inconsistent with the context includes their successors administrators executors and permitted signatories of both parties have entered in to this memorandum of understanding on the following terms and conditions

In accordance with the mutual desire to foster cooperation between IIT Mandi and AIIMS Bilaspur, Himachal Pradesh, and in order to explore the potential for collaboration in the area set out below, the two institutions have signed the following memorandum of understanding (MoU).

- A. Based on the principles of mutual benefit, both institutions intend to explore opportunities
  - 1) Joint international conference, workshop and seminar of medical and public health.
  - 2) Exchange information on research and education programs.
  - 3) Exchange information on teaching and other literature relevant to their educational and research programs.
  - 4) To jointly organize short- term continuing education programs on topics of mutual interest and to invite each other's researchers to participate therein.
  - 5) To exchange, on a reciprocal basis, researchers and students for limited periods of time for purpose of education/ research.
  - 6) To link both sides of medical industry, device and equipment, based on mutual agreements, and as per existing laws.
- B. Both institutions agree that specific projects and activities shall be developed for implementation of this memorandum based on discussions and negotiations between two institutions. Agreements or contracts shall be signed separately to carry out these projects and activities.
- C. Both institutions agree that all financial arrangements shall be determined on the basis of specific projects and activities, and will depend on the availability of funds.
- D. This MoU shall be in force for a period of 5 year from the date of its enactment. This MoU shall become effective upon the date of signature by the representative of the two institutions, and shall be renewed by mutual consent.
- E. Both institutions agree to respect each other's rights to intellectual property. Further, the intellectual property rights that arise as a result of any activity under this agreement will be worked out on a case to- case basis.
- F. Each Institution will appoint one member of its teaching/ research personnel to coordinate the program on its behalf. The coordinator, thus appointed, will periodically review and identify ways to strengthen cooperation between the two Institutions.
