IIT Mandi invites Expression of Interest (EOI) for the below mentioned Commercial Establishment in the Campus:

#### **Type of Commercial Establishment – Cafe cum Bakery Shop at South Campus**

IIT Mandi invites Expression of Interest (EOI) through e-mail for the above mentioned Commercial Establishment (**Cafe cum Bakery Shop**) in the Institute. The application with supporting scanned documents must be emailed to IIT Mandi (ceac@iitmandi.ac.in) by 05:00 pm on or before **24-01-2025**. The interested bidders/firms must have good experience of running similar services in the past for at least 2 to 3 years. It should be noted that the staff involved in running the shop should be properly dressed and shall be well trained with aspects of the work/services provided. A list of probable items to be served is attached as (<u>Annexure-A</u>).

All the bidders who intend to run the **Cafe cum Bakery Shop** at South campus, IIT Mandi are encouraged to visit the site and accordingly submit the proposal.

As part of the application, an interested vendor should submit the following details:

► **Technical Information:** It shall contain information regarding registration, experience and other details of the firm to judge the suitability of the vendor. (<u>Annexure-B</u>)

## Only those parties will be considered who are found suitable and meet the eligibility criteria decided by the Evaluation Committee. Decision of Committee after evaluating all other factors will be final in this regard.

The contract will be awarded initially for a period of one year to the successful vendor. This period may be extended in future with mutual consent, on yearly basis after reviewing the previous performance of the bidder and need of the Institute. Requirement for future extension will lie with IIT Mandi and the bidder/firm will not have any right on extension of the contract. The successful bidder/firm shall be bound to execute an agreement on non-judicial stamp paper of Rs. 100/-. The Institute considering the benefit of its residents' community, reserves the right to reject some or all the applications without assigning any reason whatsoever.

#### **Timings:**

The service hours of the above mentioned commercial establishment shall be between 9:00 AM and 09:00 PM for all seven days of the week i.e., the shop will remain open for whole of the week. The time for opening and closing of the shop may change with mutual consent which will be intimated in writing. The shop will remain open in vacations too.

#### **Rent/Charges:**

The bidder/firm shall pay monthly rent in advance @ minimum rate of Rs. 2540/- plus GST 18% etc. per month. Electricity, as per the actual at commercial tariff of HPSEB Ltd. raised by IIT Mandi, Estate Department will be charged from the bidder/firm. Also the water charges @ Rs. 100/- per month, if the separate tap is provided will also be leviable from the date of occupation. The rent can be enhanced @ 10% per annum. The rent should be deposited by 7<sup>th</sup> of every month.

The bidder can offer higher rent than Rs. 2540/- per month the minimum specified above and at Srl. No. 10 of <u>Annexure-B</u>. The rent offered by the bidder will be taken into consideration in addition to the other criteria fixed by the committee. If contract is awarded, the bidder should be in position to take over the possession immediately.

## **Security Deposit:**

The bidder shall deposit a security deposit of Rs. 50,000/- (Rupees fifty thousand only) with the Registrar, IIT Mandi, in the form of demand draft in the name of 'Registrar IIT Mandi', which shall be refunded, without any interest thereon, after the end of the contract after adjusting the amount of any damage caused to IIT Mandi by any omission or discrepancy on the part of the bidder or his employee.
